## DECISION

The Stewards, having received a report from the Clerk of the Course, heard from the Competitors' Representative and the Driver concerned, and examined the GPS protocol and video evidences and, have considered the following matter, determine a breach of the regulations has been committed by the Competitor named below and impose the penalty referred to.


**No / Driver** #115 BARBARO, Bruno Lic.-No.20054 / ITA (copy of entry form attached)  
**Competitor** KGL AMC ST. Vith  
**Session** Qualifying 2  
**Facts** no respect the prescribed speed limit under yellow flag / Code 60 conditions by MP 19 – 22  
**Time** 21:15:56  
**Offence** Breach of Article1 of Appendix 1 of DMSB Circuit Regulations (Particularities for the Nürburgring Nordschleife) and Article 28 of Supplementary Regulations  
**Decision**  
1. Late start of car #115 in the Race from the pit lane at the end of this start group plus 180 s Stop-and-Go penalty in the Race  
2. Disqualification of Driver Bruno BARBARO from the competition  
3. Withdrawal of the DPN of the Driver Bruno BARBARO  
**Reason** The Stewards consider it proven that car #115 violated excessive the speed limits in the case of a Code 60 situation when passing through the relevant sector with more than 60 kp/h overspeeding. The fact that the Driver #115 passed through this area under the same Code 60 conditions for the second time made things worse.  
In application of article 6.2 of the Appendix 2 of DMSB Circuit Regulations (Particularities for the Nürburgring Nordschleife) the Stewards made this decision as mentioned above.  
**In applying the spirit of regulations in the event of a DPN withdrawal, the Stewards see no possibility of appealing against the decision made.**

The Competitor is reminded that he has the right to appeal certain decisions of the Stewards, in accordance with article 15 of the FIA Int. Sporting Code and art. 28 DMSB General Event Regulations, within the applicable time limits.
